This school year brings many back to campus to begin working on ways to create co-requisite math courses. Governor Greg Abbott signed into law Texas HB 2223 in June 2017. HB 2223 mandates all state public institutions of higher education to develop and implement co-requisite models to deliver developmental coursework. The bill states "An institution of higher education that requires a student to enroll in developmental coursework must offer a range of developmental coursework, including online coursework, or instructional support that includes the integration of technology to efficiently address the particular developmental needs of the student." Institutions will have 3 years to phase in HB 2223, as follows:

## Recommendations for TexMATYC Constitution

According to Article VII of the TexMATYC Constitution & By-Laws, the amendment of constitution & by-laws requires 2/3 vote by members present at any regular meeting. The TexMATYC Board members have reviewed the TexMATYC By-Laws and have a couple of revisions to recommend for your vote at our next meeting while at the TCCTA convention in March 2018. Your input on these two items is appreciated and valued as our organization grows. The recommendation below shows the current stated bylaws followed by recommended by-law in parentheses. Final revised recommendation will be posted in our Spring Newsletter. Voting will take place at TCCTA convention during one of Friday's morning sessions.

# <u>Article VII - Nominations and Conduct of Election</u> of Officers

- a) In February of each even-numbered year, the President shall appoint a Nominating Committee in a manner consistent with Article VII of the Constitution and name a Chairperson of that committee. (No later than February of each even-numbered year, the President shall appoint a Nominating Committee in a manner consistent with Article VII of the Constitution and name a Chairperson of that committee.)
- b) During March of each even-numbered year, the Nominating Committee shall solicit and receive written nominations for offices up for election as indicated in Article II of the By-Laws. Any member

with current voting eligibility may nominate himself or herself or any other eligible member of the Association. The written nomination shall include a current vita or resume for the nominee. (No later than March of each even-numbered year, the Nominating Committee shall solicit and receive written nominations for offices up for election as indicated in Article II of the By-Laws. - c) Prior to April 15 of each year the Nominating Committee shall:
- i. select from the nominees two candidates for President-Elect, Secretary, and Treasurer, and in addition provide on the ballot a blank for write-in voting for each office and (select from the nominees two candidates for President-Elect, Secretary, and Treasurer, and in addition provide on the ballot a blank for write-in voting for each office and)
- ii. send e-mail ballots to all members eligible to vote. The form of the ballot and directions for return of the ballot shall be determined by the Nominating Committee. The election shall be completed in time for publication of the Association Newsletter prior to June 1. (send e-mail ballots to all members eligible to vote, if voting needs to occur after annual spring meeting. The form of the ballot and directions for return of the ballot shall be determined by the Nominating Committee. The Newsletter Editor/Webmaster shall be appointed by the President with the approval of a majority of the Executive Board for a minimum of two years and shall be subject to reappointment. A member of the Executive Board may hold one of these roles in additional to their current position on the Board.)

- 2. The student must be nominated by an AMATYC member who is an employee of the qualifying institution.
- 3. The student must have an overall GPA of at least 3.0.
- 4. The nominated students must be majoring in mathematics and enrolled full-time at the nominating institution during the spring semester preceding the Annual AMATYC conference when the award will be announced.

# AMATYC Presidential Student Scholarship

We are privileged to recognize students who excel in mathematics! If you have a student who meets these criteria, please submit their name to TexMATYC for consideration. We will make the final determination as to who represents Texas in this nomination. Deadline to submit your student nomination with support letter to TexMATYC is Friday, October 6, 2017. #### **Purpose of the Award**

The purpose of the AMATYC Student Scholarship is to encourage the study of mathematics by students enrolled in institutions of higher education.

#### Criteria

1. Each affiliate may submit one nomination from a student attending a qualifying institution. To be a qualifying institution, the institution must employ at least one member in good standing of AMATYC.
