## **President's Message**



**Greetings Colleagues** 

The Fall 2019 semester is upon us and as we close-out our second decade of the 21st Century, we can reflect on the changes that have defined our shared work during this time. The 2010's started with record enrollment at community colleges across the state. An influx of dual enrollment programs offering high school students the opportunity to earn not only college credits but, in some cases, a full Associates degree, took hold in our respective communities!

Technology, in the form of: enhanced calculators, computers/laptops/tablets/cell phones, 24-7 internet accessibility, mathematics software & applications, Learning Management Systems (LMS), and video instruction have become a near everyday component of our work as Mathematics educators. With all of these great changes abound, there are always challenges to face and overcome.

Currently, enrollment has stalled at community colleges in Texas and many new for-profit educational programs are popping-up in our communities creating competition vying for our students. Dual credit enrollment has grown at such a rapid pace that many community colleges are reaching a threshold of capacity to support the overwhelming demand brought-forth by the local high school districts. Technology has proven to be both a blessing and curse: instruction can now be provided to our students anywhere at any time and that means that we, as educators, are now expected to be available anywhere and anytime.

With specific regard to dual credit, the 86th Texas Legislature recently passed three bills of notice and importance: SB 1276 requires high school Endorsements to be strategically aligned to college Pathways; SB 1324 states that dual credit students, after the completion of two semester or 15 credit hours, must declare a college major; and HB 3650 requires detailed support and alignment for dual credit programs including a provision requiring school districts to consider the use of free or low-cost open educational resources.

All of this discussion brings me to a recurring theme: Equity & Accessibility in Mathematics Education. With so much information available online and with a currently all-time low in job unemployment, our community of Mathematics Educators needs to consider how the mathematics that we teach is accessed and shared with our students and communities during these changing times.
